



2020 Summer Day Camp Program REGISTRATION FORM

Hello Parents,

Due to the current situation involving COVID19, TKC will not be able to offer the full summer day camp program that was offered last year; however, we will be providing fun summer activities 3 days per week for the month of July. TKC will be following the guidelines provided by the Chief Medical Health Officer and will be limiting our group of campers to 7 participants each day, along with 3 staff, to maintain the 10-person group limit. We are welcoming children **ages 7-12** to participate in this year's programming. The TKC summer program will prioritize seats for TKC children but will accept children of TKC Citizens and non-TKC children if space is available.

Parents will be responsible for drop-offs and pick-ups at Rotary Park, and TKC will be providing transportation to and from all activities. If parents wish to provide transportation to and from activities as well, please note this preference on this application or discuss your preference with the Camp Coordinators prior to your child's session(s). Lunch will not be provided this year, so we ask participants to bring all the food and snacks that they will need for the day. Staff will ensure that extra water is brought to all activity sites.

As our programming will take place outdoors this summer, there is the possibility that some sessions that are cancelled due to poor weather. We will try to provide alternate programming indoors if this occurs and will do our best to communicate any changes to parents or guardians in a timely manner. Please ensure that your child comes to camp prepared with appropriate clothing (jacket, hat, change of clothing), a lunch and snacks to get them through the day, and a positive attitude. We have a variety of fun activities lined up, and we expect to have an awesome time this summer!!!

We will be breaking each week into one day of TKC-lead activities and two days of facilitated activities. Participants can apply to two of the four TKC-lead activities and four of the eight facilitated activities. Please note, the facilitated activities will be the same activity offered on both days.
