- **FLU SHOTS NOW AVAILABLE IN WHITEHORSE – Daily Clinics, Yukon Convention Centre**  
TKC Citizens interested in getting an annual flu shot can now do so. Regular clinics will be held starting October 26 until December 17, 2020. All clinics will take place this year at the Yukon Convention Centre (4051 4th Avenue). Typically, influenza is a seasonal disease. In Yukon, we normally start seeing our first cases in late December or January. This fall and winter, flu viruses and COVID-19 may both spread. It is more important than ever that Citizens protect themselves, and others, from all respiratory illnesses – including the flu. Although immunization is the best way to prevent influenza, good respiratory hygiene is very important especially during cold and flu season. This includes always coughing or sneezing into your elbow or a tissue, always disposing of tissues right away and washing your hands often and regularly with soap and water. - **TKC CITIZENS MAY BENEFIT FROM SELF-GOVERNMENT RULES ON PENSIONABLE EARNINGS**  
TKC has approved an amendment to the TKC Self Government Agreement (SGA) that might result in some Citizens seeing a tax reimbursement through their registered pension plans. The amendment will affect Citizens who were Status Indians under the *Indian Act* and who contributed to a registered pension plan between April 1, 2003 to April 1, 2006. The SGA amendment states they should have been exempt from paying income tax during that time and will be reimbursed if they paid income tax on their registered pension plan. This is dependent upon federal approval of this SGA amendment which is now before the Government of Canada. All information provided will be kept strictly confidential and will be used in a report outlining recommendations to the Yukon's Justice Minister for the 2021-2022 fiscal year.
