# TERMS OF REFERENCE (TOR) FOR THE EDUCATION COMMISSION

# **AUTHORITY**

1. The Education Commission (the "Commission") shall derive its authority from Chief and Council Resolution 2009—03, "Establishment of the Ta'an Kwäch'än Council Education Commission," (Appendix 1 passed by consensus on 3 February 2009)

and

Motion 2017-05-06 (May 24, 2017) "To approve the Ta'an Kwach'an Council Terms of Reference for the Education Commission as presented.

#### **CURRENT CONTEXT**

- 2. The Ta'an Kwäch'än Council delivers comprehensive Education programming for citizens that supports life-long learning. Some of the funding that support these programs is administered on behalf of Canada and is subject to the relevant program policies and guidelines.
- 3. Under its final and self-government agreements, the Ta'an Kwäch'än Council has the authority to negotiate the devolution and assumption of responsibility for the management, administration and delivery of certain education and training programs and services within the jurisdiction of the Ta'an Kwäch'än Council.

#### MANDATE AND SCOPE OF ACTIVITIES

4. The Commission shall have authority over Education programming and shall guide the educational and training programs and services provided by the Ta'an Kwäch'än Council.

Specifically, the Commission shall:

- a.) carry out its duties and responsibilities in accordance with TKC's Education Policies;
- b.) participate as TKC representatives in Education Initiatives impacting on TKC Citizens;
- c.) advise and assist, when requested, the Manager of the Education Department;
- d.) make recommendations and report, when required, to Chief and Council; and
- e.) perform such other tasks that fall within the mandate and scope of activities of these *Terms* of *Reference*.

#### **PROCEEDINGS**

- 5. To achieve the tasks set out in section 4 of these *Terms of Reference*, the Commission shall:
  - a.) appoint the Education Manager as Chair (ex-officio "Chair") of the Commission;
  - b.) meet on a regular basis, minimum of three times a year;
  - c.) review these *Terms of Reference*, including the *Appendices* listed under section 22 of these *Terms of Reference* on an annual basis; and

d.) establish and make available to Chief and Council a schedule of meetings of the Commission.

# REPORTING

6. The Chair shall provide Chief and Council with summary reports of the activities of the Commission, as required.

#### BUDGET

- 7. The Education Manager, with input from the Commission, will prepare an annual work plan and operating budget.
- 8. The work plan and operating budget for the Commission shall be reviewed for approval as part of the annual Ta'an Kwäch'än Council budgeting process.
- 9. The Chair shall monitor the work plan and operating budget for the Commission and shall provide updated reports as needed.

# **HONORARIA**

10. The members of the Commission shall receive an honorarium in accordance with paragraph 3(b) and subsections (4) and (5) of the Honoraria Regulation (2007), TKC/01-Ch1.

#### **VALUE AND ETHICS CODE AND OATH OF SECRECY**

11. Each member of the Commission, upon his or her appointment, shall sign the "Value and Ethics Code and Oath of Secrecy of Committee Members."

# **MEMBERSHIP**

- 12. The Commission shall be composed of a representative from each of the five traditional families, appointed by Chief and Council for a term of three years.
- 13. Commission members may be reappointed.
- 14. The Manager and staff of the Education Department shall be ex-officio representatives on the Commission.

#### **QUORUM**

- 15. The quorum of the Commission shall be no less than three members.
- 16. Quorum is required for any decisions.
- 17. In situations where a majority of members are unable to meet face-to-face, quorum may be achieved with the assistance of technology.
- 18. The Commission will strive for consensus decision-making.

#### **COMMUNICATION OF DECISIONS**

19. All decisions made by the Commission regarding student applications, requests and appeals shall be communicated in writing to the students in accordance with Education Policy.

# **LOCATION OF MEETINGS**

20. The meetings of the Commission shall be held in a location to be determined by the Chair and may be held in-person or with the assistance of technology.

# **REVIEW OF THE TERMS OF REFERENCE**

21. The Terms of Reference for the Commission shall be reviewed annually.

# **LIST OF APPENDICES**

22. In addition to the appendices listed under this section, the Commission may request any documents and information it deems essential to perform its mandate and scope of activities from the Ta'an Kwach'an Council.
